Smith.

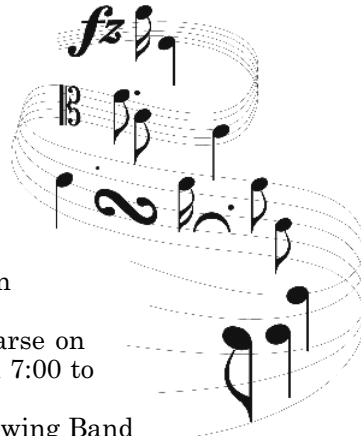
The Swing Band is looking forward to its return visit to The Masonic Home and Overlook in Charlton, MA.

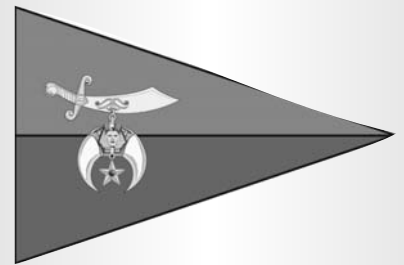
# Shriners Lost at Sea?
